Hazards identification</b>	<p>This product is not classified as dangerous according to EU Directive 1999/45/EC.</p> <p>Eye contact:            Transient superficial irritation.</p> <p>Skin contact:           Prolonged exposure may cause skin irritation</p> <p>Ingestion:              Possible mild gastro-intestinal irritation with nausea and vomiting.</p> <p>Inhalation:              Inhaling of particles may cause mild irritation of the respiratory system.</p>
